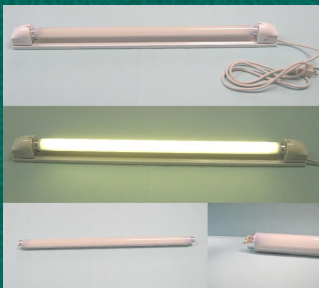

→ AEP Ohio wants you to buy less electricity!

In a surprising turn of events, over the past year electric utilities across Ohio have begun actively trying to get their customers to use LESS POWER! AEP Ohio and the other investor-owned utilities, FirstEnergy, Dayton Power & Light, and Duke Energy, are all rolling out new programs to encourage you to make changes to use less electricity. Why would they want you to use - and charge you for - less? The utilities have realized that using the power plants they already own smarter is cheaper, and makes profits higher, than building new ones to meet growing needs, even when sales are lower. But even more importantly, [Senate Bill 221](#), passed in 2008, states that investor-owned utilities must implement energy efficient programs in order to meet annual energy savings goals - or pay fines.

The Public Utilities Commission of Ohio (PUCO) regulates costs and prices (and profits) for the states utility companies and they have approved a small fee to be added to each AEP Ohio customer's electric bill to pay for running these savings programs. Starting this month, about \$3 a month will be added to your bill. That adds up to \$36 a year. But there are ways for you to get that money back.
